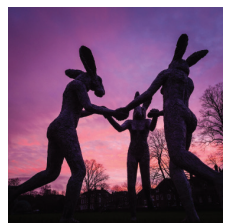
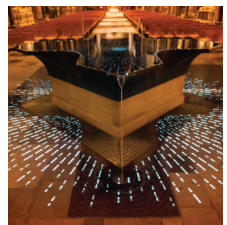
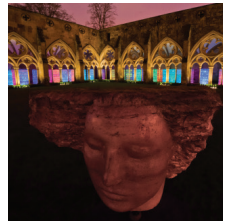
Support art at

Supporter: £120 per year

£60 per year could provide a free family workshop during an exhibition.

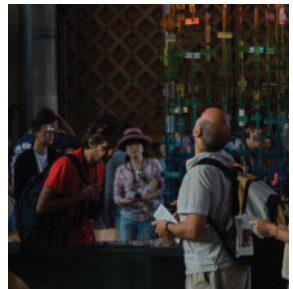
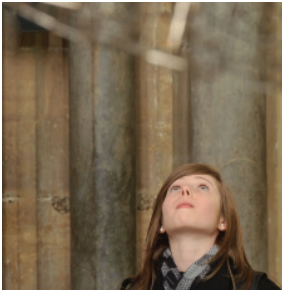
